Assembly Resolution 7: Student Government Supports the Student Voice

Whereas, the Graduate Student Assembly is advised by Victoria Rodriguez who is the Dean of the Graduate School and a Vice Provost of the University, which mirrored the communication structure of Student Government and the Dean of Students office before reorganization; and,

Whereas, for the past several years the Student Government at the University of Texas and the Senate of College Councils have been advised by an Assistant Dean of Students, who reported directly to the Dean of Students; and, [1]

Whereas, the Senate of College Councils is jointly advised by an Assistant Dean of Students and the Executive Vice President and Provost; and,

Whereas, in this previous structure the central administration at the University of Texas represented a commitment to student representation and the empowerment of the student voice; and,

Whereas, a recent reorganization within the Office of the Dean of Students resulted in an additional level of reporting between the Student Government advisor and the Dean of Students; and, [2] [3]

Whereas, this reorganization has weakened the link between the student voice and the administration.

Now, Therefore Be It Resolved, that the Student Government at the University of Texas recognizes the importance of a good working relationship between administrators and students; and,

Be It Further Resolved, that the Student Government at the University of Texas is concerned that the reorganization within the Office of the Dean of Students may increase the distance between administrators and students; and,

Be It Further Resolved, that the Student Government at the University of Texas recognizes that this increased distance between administrators and students weakens student representation and the importance of student voice; and,

Be It Further Resolved, that the Student Government at the University of Texas pledges to students to uphold the importance of the student voice by strengthening the influence and governing potential students have with the administration; and,

Be It Further Resolved, that the Student Government at the University of Texas ardently appeals that the administration of the University re-assert their commitment to students by increasing the level of dialogue between students and top-level university-wide administrators; and,

Be It Further Resolved, the Student Government at the University of Texas wishes to have a voice in important changes like these; and,

Be It Further Resolved, that the Student Government at the University of Texas recognizes the importance of the Student Government Advisor position and asserts that the next Student Government Advisor, and any Interim-Student Government Advisors should have a title of Associate Vice President or higher; and,

Be It Further Resolved, that the Student Government at the University of Texas endorses no specific candidate at the time and requests an open and inclusive selection process for the next Student Government Advisor and any Interim-Student Government Advisors; and,

Be it Further Resolved, this resolution should be forwarded to all University Vice Presidents and President William Powers.

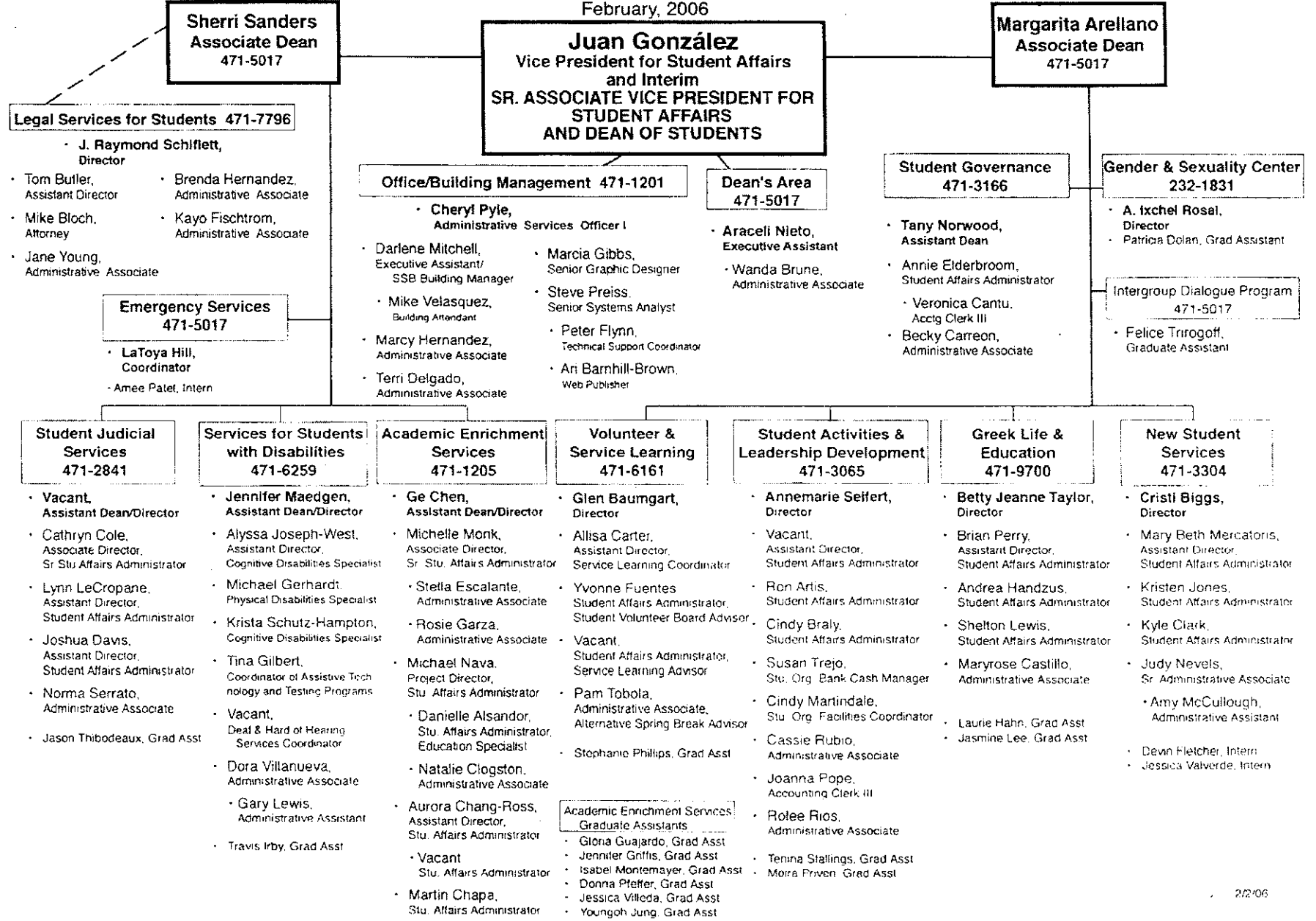

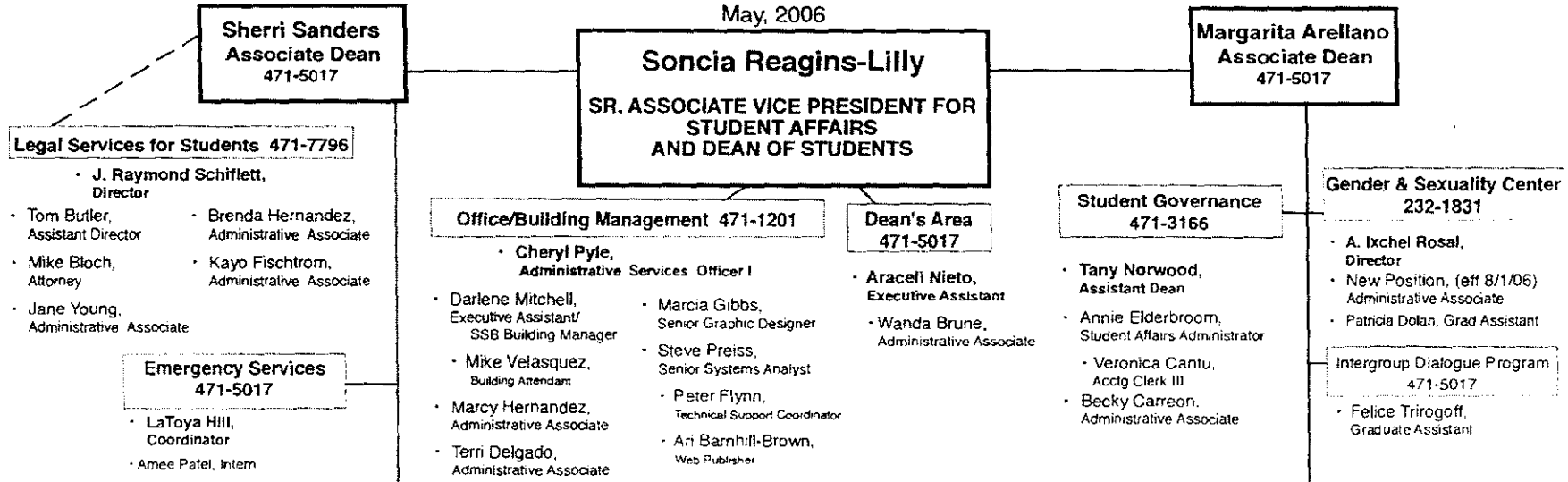
