

UT Student Government Assembly Meeting - 10/5/99  
7:00 PM Glenn W. Maloney Student Assembly Room

A regular meeting of the Student Assembly of the Student Government of the University of Texas at Austin was called to order at 7:10 PM on October 5, 1999 in SSB G1.310. Secretary Lora took the minutes.

Roll was called at the beginning of the meeting with the following Representatives, Committee/Agency Heads, and Executive Board Members not present: Babcock, Cash, Gardner, Halstead, Hammond, Jovel, Mehta, Pichardo, Putman, Smith, Chao, Buchek, Cunningham, Lissner.

The minutes were approved.

Guests: Brooke Grona, University Ombudsman

Representative Raman moved to suspend the rules to allow AP 2, 3, 4, 5, 6, 7, 8, & 9 to be the next items of business. Representative Woods seconded. Passed.

Representative Quintanilla moved to suspend the rules to move AP 5 to be the last item on new business. Representative Camacho seconded. Passed.

New Business

AP 2 - Texas Onyx has declined to accept the money.

AP 3 - UT Juggling Society - Representative Davis introduced them. They would like to buy yellow balls for people to juggle. They received \$80. No debate. Passed.

AP 4 - National Community Pharmacist Association - Representative Buchan introduced them. They want to use the money to send people to a conference. They received \$120. No debate. Passed.

AP 6 - Alpha Phi Omega - Representative Garner introduced them. They will use this money for blood drive publicity.

Representative Quintanilla moved to increase the allocation from \$150 to \$325. Representative Garner seconded. Failed.

There was no debate for giving APO the original \$150. Passed.

AP 7 - Naval ROTC - Representative Woods introduced them. They are planning to run from our stadium to Cotton Bowl stadium for OU weekend and would like to use this money for the hotel. They received \$104. There was no debate. Passed.

AP 8 - Kappa Delta Chi - Representative Camacho introduced them. They are planning a Latino faculty/student/staff mixer and would like to use the money to pay for the guard. They received \$240. There was no debate. Passed.

AP 9 - Mortar Board - Representative Patel spoke on behalf of Mortar Board. They would like to use the money to help pay for their Preferred Professor dinner. They received \$118. There was no debate. Passed.

Representative Garner moved to reconsider the vote on AP 6 to change the amount that APO was awarded from \$150 to \$200. Vote. Division was called. (13 for, 9 against). Passed.

Business is now to reconsider AP 6. Debate.

AGAINST - Representatives Gross & Dickerson - We may want to wait until we have heard from everyone or consider to give the money to groups who received nothing.

FOR - Representative Garner - The amount of publicity really does affect the number of donors they'll get, and they can't afford to wait until the end of appropriations after we've heard from everyone because the blood drive will be over.

Vote. Failed. The amount stands at \$150.

Representative Davis moved to suspend the rules to move the Student Volunteer Center request for appropriations from next Tuesday's agenda to tonight's agenda. Representative Murphy seconded. Passed.

AP 10 - Student Volunteer Board - Davis spoke on their behalf. They received \$280. There was no debate. Passed.

### Open Forum

1. Robby Slaughter talks about considering all of the appropriations carefully.

Representative Day moved suspend the rules to move AP 5 to the next item of business and to make him the sponsor. Passed.

AP 5 - Institute of Latin American Studies Student Association - Day introduced them. They would like to use this money to help put on a student conference at UT. They were allotted \$250 for t-shirts. Debate. Vote. Division was called. (19 for, 3 against). Passed.
