Lynn Baker and **Charles Silver** submitted an Amicus Brief, Supplemental Amicus Brief, and Supplemental Letter Brief in <u>Burrow v. Arce</u>, decided by the Texas Supreme Court on July 1, 1999.

Hans Baade's Comparative Law: Cases, Text, Materials (6th ed. 1998; with Rudolf B. Schlesinger, Peter E. Herzog, & Edward M. Wise) was reviewed in 10 European Journal of International Law (1999).

Robert Dawson was quoted in the Houston Press, July 1, 1999, on a Houston juvenile court judge's controversial practice of forcing families to pay for court-appointed attorneys.

Steven Goode will present an update on evidence at the State Bar's Advanced Civil Trial Course in Fort Worth, Sept. 2, 1999; in Houston, Sept. 30, 1999; and in San Antonio, Nov. 4, 1999.

Lino Graglia commented in the Los Angeles Times, July 6, 1999, on the political motives behind the increasing activism of state attorneys general in business regulation and consumer protection litigation. **Graglia** was quoted in the Investor's Business Daily, June 16, 1999, on recent Supreme Court cases invalidating federal legislation.

Patricia Hansen delivered a talk on "The Impact of NAFTA On Private Rights" to a group of state and federal judges from the United States and Mexico, at the Border Conference of the U.S./Mexico Judicial Exchange Program, in San Antonio on July 18, 1999. **Hansen** will give a series of lectures on the North American Free Trade Agreement to a group of Mexican attorneys, judges, and law students, as part of a law program sponsored by the UT International Office, on July 26-27, 1999.

Henry Hu was quoted in Business Week, July 12, 1999, at 45, on the role played by the plaintiffs' bar in the quality of disclosure in U.S. securities markets relative to the quality of disclosure in foreign markets.

Douglas Laycock was quoted in the June 25, 1999, Chronicle of Higher Education on U.S. Supreme Court decisions concerning state funding of church-supported schools; and in the July 2, 1999, issue on the Court's ruling that states are immune from lawsuits alleging patent law violations. **Laycock** was quoted in Reason, July 1, 1999, on the 9th U.S. Circuit Court of Appeals decision which upheld the right of landlords to reject unmarried couples as tenants for religious reasons.

Vis International Commercial Arbitration Moot, held in Vienna, Austria, Mar. 26-Apr. 2, 1999. **Rau** presented a paper on "Dispute Resolution in Commercial Law" at the Master of European and International Business Law Program, University of St. Gallen, Switzerland, May 7, 1999.

Michael Sturley attended the spring meeting of the Maritime Law Association of the U.S. in New York City, where he co-chaired a meeting of the MLA's Marine Insurance Study Group on May 3, 1999, and spoke to the MLA Committee on the Carriage of Goods, May 5, 1999, on the status of the proposed amendments to the Carriage of Goods by Sea Act. **Sturley** attended the annual meeting of the editorial board of the Journal of Maritime Law & Commerce, as the journal's book review editor. During the first week of August, **Sturley** will be the annual Marine Insurance Distinguished Visitor at the University of Cape Town's Institute of Marine Law.
