1 • AS CONSEQUENCE CPA EXECUTIVE DECISION PROTEST SOVIET INTERVENTION IN CZECHOSLOVAKIA (REFTEL), CPA NATIONAL PRESIDENT R. DIXON AND VICE PRESIDENT J. SENDY CALLED ON SOVIET CHARGE IN CANBERRA AUGUST 22. AT CONCLUSION SIX HOUR MEETING DIXON TOLD PRESS CONFERENCE: "ON BEHALF CPA NATIONAL EXECUTIVE I URGED SOVIET UNION RECONSIDER POSITION OF SOVIET TROOPS IN CZECHOSLOVAKIA AND WITHDRAW THEM. FURTHERMORE I ASKED THAT PROTEST OF CPA BE FORWARDED TO CENTRAL COMMITTEE OF SOVIET COMMUNIST PARTY - MR . PLUSTCHENKO (SOVIET CHARGE) SAID HE FOUND IT DIFFI-CULT UNDERSTAND POSITION WE HAD ADOPTED. IN HIS VIEW SITUATION IN CZECHOSLOVAKIA HAD DETERIORATED AND THERE HAD DEVELOPED REAL! DANGER OF RESTORATION OF CAPITALISM, AND IF THAT HAPPENED IT COULD LEAD TO POSSIBILITY OF WORLD WAR THEY HELD VIEW IN THESE CIRCUMSTANCES BEST THING TO DO WAS TO ACT NOW RATHER THAN TO ALLOW SITUATION TO DETERIORATE STILL FURTHER. UPON THAT POINT WE DISAGREED AND I SAID THAT WE BELIEVED SOURCE

OF DIFFICULTIES IN CZECHOSLOVAKIA CAME FROM POLICIES PURSUED BY NOVOTNY GOVERNMENT AND WHAT WAS NEEDED WAS TO BRING ABOUT CORRECTION OF THESE POLICIES. WE BELIEVE NEW GOVERNMENT AND LEADERSHIP OF PARTY UNDER DUBCEK WAS LEADING TO CORRECTION OF MISTAKES OF PREVIOUS GOVERNMENT."

2. AT SAME TIME DIXON PROTESTING TO SOVIET CHARGE, CPA
OFFICIALS DELIVERED SIMILAR PROTESTS TO POLISH, HUNGARIAN,
AND BULGARIAN CONSULAR OFFICES IN SYDNEY, THIS WAS ACCOMPANIED
BY PUBLICATION SPECIAL EDITION CPA NEWSPAPER "TRIBUNE" WHICH
FEATURED PROTESTS AGAINST SOVIET INTERVENTION IN CZECHOSLOVAKIA.

3. PARALLELING ABOVE PROTESTS, TWO "PEACE" ORGANIZATIONS
(PUBLICLY LABELED BY AUSTRALIAN ATTORNEY GENERAL AS COMMUNIST
FRONTS) WHICH NORMALLY ENGAGE THEMSELVES FULL TIME IN ANTIVIETNAM AND ANTI-CONSCRIPTION ACTIVITIES STRONGLY CONDEMNED
SOVIET ACTIONS. ASSOCIATION FOR INTERNATIONAL COOPERATION AND
DISARMAMENT SAID IT "CONDEMNS AND PROTESTS IN STRONGEST
POSSIBLE LANGUAGE FLAGRANT AND UNPROVOKED VIOLATION OF CZECH
NATIONAL INDEPENDENCE, TERRITORIAL INTEGRITY AND SELF-DETERMINATION BY SOVIET UNION." VIETNAM ACTION COMMITTEE SAID IT "UNEGUIVOCALLY CONDEMNS BRUTAL SOVIET INVASION AND OCCUPATION
OF CZECHOSLOVAKIA."
