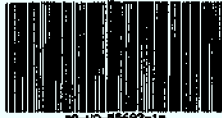

On April 2, 1973, the facts involved in this matter were discussed with Assistant U. S. Attorney John F. Penrose, Eastern District of Pennsylvania, for the purpose of obtaining a prosecutive opinion. Mr. Penrose declined authorization of prosecution based upon investigation to date reflecting a long history of such activity by the subject. There was no indication of any overt acts and no local arrest record. It was noted that he has been a prolific letter writer without any known harmful or aggressive activity. [REDACTED]
