Amending The Code of Rules and Procedures to Advance the Swearing-In of Appointments

IN THE UNIVERSITY OF TEXAS AT AUSTIN STUDENT GOVERNMENT

BE IT ENACTED BY THE UNIVERSITY OF TEXAS AT AUSTIN STUDENT GOVERNMENT:

SEC 1: Amend Chapter 1, Article II, Sec. 2.3 in the Code of Rules and Procedures as follows:

Sec. 2.3 ASSEMBLY AGENDA. The agenda for the Assembly meeting shall have the following format:

- (a) Call to Order;
- (b) First Roll Call;
- (c) Approval of the Minutes from the Previous Assembly Meeting;
- (d) Guests;
- (e) Open Forum;
- (f) Appointments:
 - i. Assembly Appointments;
 - ii. Internal Appointments;
 - iii. External Appointments;
 - iv. All appointments shall be sworn-in by the Chief Justice or a Justice of the Supreme Court;
- (a) Unfinished Business;
- (b) New Business;
- (c) Ex-Officio Member Reports:
 - i. Senate of College Councils;
 - ii. Graduate Student Assembly;
 - iii. Campus Events and Entertainment;
- (d) Deputy Advisor Report;
- (e) Executive Board Reports;
- (f) Cabinet of Policy Director Reports;

- (g) Agency Director Reports;
- (h) External Appointment Reports;
- (i) Executive Staff Reports;
- (j) Standing Assembly Committee Reports;
- (k) Representative Reports;
- (l) Judicial Report;
- (m) Ad hoc Reports;
- (n) Speaker of the Assembly Report
- (o) General Announcements;
- (p) Second Roll Call;
- (q) Recess/Adjournment.

SEC 2: Amend Chapter 1, Article II, Sec. 2.21 in the Code of Rules and Procedures as follows:

- Sec. 2.21 JUDICIAL REPORT. The Chief Justice or a Justice of the Supreme Court shall deliver the Judicial Report to discuss any pending judicial matters for up to five (5) minutes.
- (a) The Chief Justice or a Justice of the Supreme Court shall discuss any advisory opinions they deliver or any resolved petitions.

SEC 3: This bill shall be sent to the Dean of Students, the Deputy Advisory to the Dean of Students and the Vice President of Student Affairs. This bill shall take immediate effect until and unless one or more of those entities objects.

SEC 4: The Assembly Clerk shall update the Code of Rules and Procedures and provide an electronic copy to the Communications Director, who shall update the SG website accordingly.


