- [1] Whereas All students at the University must be enrolled in a specific college
- [2] **Whereas** advising for students is college specific, such that an advisor may not be able to discuss opportuni that are outside a college or that span several colleges
- [3] **Whereas** some interdisciplinary programs[1] are housed in a specific college that may not reflect the compl scope of the program
- [4] **Whereas** housing an interdisciplinary program in a specific college exposes the interdisciplinary student to degree requirements separate from their main academic focus

- [7] **Whereas** college-wide interdisciplinary study majors exist at Harvard, Stanford, Yale, Berkeley, UCLA, USC, Northwestern, Illinois, Duke, Virginia, and other institutions[3]
- [8] **Whereas** the University is currently undergoing a comprehensive review of its structure and curriculum as p of the Commission of 125 initiative
- [9] **Be It Resolved** the Student Government of the University of Texas at Austin supports the creation of a university-wide, degree-granting program for undergraduate interdisciplinary study at the University
- [10] **Be It Further Resolved** the Student Government requests that significant resources for student advising | allocated to such a program
- [11] **Be It Further Resolved** the Student Government requests that this issue be considered as part of the campus-wide review of curriculum currently underway and that student input continue to be solicited
- [12] **Be It Further Resolved** the Student Government requests that information regarding student and faculty interests be collected and considered by administrators and student representatives before such a program is created and that Student input Continue to be Solicited
