There was no unfinished business.

### New Business

Representative Hammond moved to suspend the rules to allow for the consideration of AR 25 and AB 13. Representative Gross seconded. Passed. AR 25 and AB 13 are now added to the agenda.

#### AR 24 - Endorsing Service-Learning

President Fatehi introduced the resolution. Basically, we're showing our support to the students who are working to make this happen. Representative Quintanilla moved to call question. Representative Gross seconded. Passed. AR 24 passed.

#### AR 25 - Sponsoring "Hook the Vote '99"

President Fatehi introduced the resolution. This resolution has heavy implications because people who vote once will probably continue. We're just trying to get as many students as possible to vote in the upcoming election. Representative Gross moved to call question. Representative Levy seconded. Passed. AR 25 passed.

# AB 13 - Providing for a Student Body Referendum to Amend the Student Government Constitution

This will allow SG to change the constitution to allow for the advocacy of issues. If it passes tonight, it will be on the ballot for the October 5-6 referendum. General discussion took place.

FOR - Representatives that spoke for AB 13 were Representatives Quintanilla and Hammond. Reasons for included that important issues sometimes need our help to inform students and get them to vote on them. We have the potential to make a huge difference on important issues. It doesn't necessarily need to be on the October referendum, it just says the earliest possible date.

AGAINST - Representatives that spoke against AB 13 were Representatives Rosen and Friedberg. Reasons against included that we may not be able to accurately represent the concerns of all students if we're taking sides on issues. Friedberg yielded the floor to Brian Ferguson, ESB chair, who also spoke against AB 13. Other reasons included the huge expense that may be incurred by adding this to the agenda at such a late time. In addition, there will also be resistance

from health services. This referendum is only being held at three voting locations. We might want to consider doing this during the spring election so that we won't have to pay for it.

Representative Friedberg made a motion to limit speakers to 2 minutes. Representative Woods seconded. Passed.

AGAINST - Representatives Friedberg, Fundraising Chair Gupta, Davis, Rosen - We might want to table it so that we can talk to other students first. Gupta yielded the floor to Robby Slaughter. Perhaps we may want to refer this to a focus group.

Representative Michels moved to table AB 13. Representative Woods seconded. Point of information: it was never actually introduced.

FOR - Representatives Gross, Levy - Perhaps this should be changed because it's out of date. We do need to talk to students, but they elected us to represent them and we should do things in their best interest.

Representative Woods moved to end debate. No second.

Vice-President Opiela yielded the chair to Attorney General Olcott.

Vice-President Opiela officially introduced the bill. The main reason he brought this forward now is because this is a hot issue right now. Right now we have the support of many assembly members and the Daily Texan. If we pass this tonight, and the student body passes it in October, we have a better chance of making it happen than if we try it in the spring. By March and April, people will forget this happened and the board of regents may not remember it and won't pass it. Debate.

FOR - Representatives Hammond, Halstead, Vice-President Opiela - The reason we don't need to table this is because it's going on the referendum to ask students what they think. We're voting on whether we want to ask students. Everyone is going to get a chance to vote. We also may be able to change the way the vote is conducted.

AGAINST - President Fatehi - She's for us having this advocacy power. However, if it passes tonight it is going on the October referendum at 4 locations without voter pins and volunteers. The turnout may not be good, so perhaps we should wait until spring.

Representative Hammond moved to call the question. Representative Murphy seconded. Division called. (14 for, 12 against). Motion carried.

Motion is to approve AB 13.

Representative Friedberg moved for roll call vote. Failed.

Point of information: A 2/3 vote was need to call the question, so technically the motion to call the question failed. More debate.

Representative Friedberg moved to table the bill. Representative Halstead seconded. Division called. (12 for, 11 against). Passed.

Representative White made a motion to reconsider. Representative Gross seconded. Passed. More debate.

Representative Friedberg moved to table it. Representative Friedman seconded. Motion failed. More debate.

Representative Rosen moved to table it until we can find out if it can even be on the ballot. Representative Friedberg seconded. Division called. (12 for, 11 against). Motion is tabled.
