MINUTES

A special meeting of the Students' Assembly of the Students' Association of the University of Texas at Austin was called to order at 7:10 P.M. on April 26, 1994, in Main 212. Vice President Forbes was in the chair and the secretary was present.

The roll was called and the following representatives were absent: Junell, Mattei, McRae, Wilson, Young-Education.

The minutes were approved.

There was a special presentation regarding the new IDs that was given by Laurie Mackey.

The President, Vice President, Executive Director, Chair of the Cabinet of College Council, and Financial Director gave their reports.

The Attorney General was not appointed due to controversy regarding A.R. 11. Rep. Wynne motioned to yield the floor to a non-member. Rep. Almuti motioned to let Rep. Aruh speak about A.R.11 S.A. GOVERNING DOCUMENTS. Rep. Pigg motioned to let Rep. Almuti speak. Rep. Garcia motioned to move into debate. Rep. Wynne motioned to move out of debate. Rep. Sheffield motioned to table the appointment until next week's meeting.

Almuti made the motion to accept by acclamation. Students' Forum Chair, Mark Adkins; Rep. Aruh made the motion to accept by acclamation. Texas Union Board of Directors, Colby Harmon; Rep. Aruh made the motion to accept by acclamation. Student Services Chair, Prescott Caballero; Rep. Keith made the motion to accept by acclamation. Student Services Fee Committee, Fareed Tulbah; Rep. Keith made the motion to accept by acclamation. SURE Walk Director, Jennifer Loev; Rep. Beck made the motion to accept by acclamation. SURE Education Coordinator, Jennifer Sancton; Rep. Aruh motioned to accept by acclamation; this was objected. Rep. Aruh then called previous. Ms. Sancton was voted in by the Assembly unanimously. University Council, Camille

Purvis; Rep. Beck motioned to accept by acclamation. University Council, Josh Aruh; Rep. Keith motioned to accept by acclamation. Multicultural Affairs Chair, Tamara Bowens; Rep. Keith called to previous question. Ms. Bowens was voted in unanimously. Two-Year-at-Large, Eddie Bravenec; Rep. Almuti motioned to accept by acclamation. Citizens' Affairs Chair, Wesley Wynne; Rep. Keith motioned to accept by acclamation. Citizens' Affair Vice Chair, Ellice Perez; Rep. Keith motioned to accept by acclamation. Student Services Vice Chair, Stephanie Soffar; Rep. Music motioned to accept by acclamation. Election Supervisory Board Chair, Jeff Monk; Rep. Almuti motioned to accept by acclamation. Texas Union Board of directors, Jaspreet Pal, and Volunteer Center Intern, Michael Danziger were both tabled.

The newly approved members were sworn in.

The following members spoke under Members Privilege: Garcia, Almuti, Keith, Feld, Aruh (Reps. Keith and Steinberg motioned for extra minutes for Rep. Aruh to speak), McFadden, Wynne, Sheffield, Wilkov, Caballero, Eastman, Pigg, Forbes, Purvis, Hasan, Simon, and Pappas.

Under New Business, A.R. 2 ADHERENCE TO SCHEDULING- Ex. Dir. Eastman motioned to amend the bill and to vote on the two amendments separately. The bill was amended as follows: "freedom" was changed to "procedure," and the first whereas clause clause was taken out. Rep. Keith motioned to take out the first whereas clause. Rep. Garcia motioned to take out the word "freedom" and to replace it with the word "procedure." Rep. Keith motioned to table the resolution. The resolution was tabled. Rep. Caballero motioned to suspend the rules in order to hear A.B. 3 MODIFICATION OF ATTENDANCE REQUIREMENTS FOR STUDENTS' ASSEMBLY REPRESENTATIVES. The Assembly then moved into Committee of a Whole. Rep. Keith motioned to move out of Committee. Rep. Pigg motioned to amend A.B. 3 by adding SECTION 4, Article IV, part A, "...or a maximum of two days after the event." Rep. Pigg motioned to send the bill to committee. Rep. Garcia motioned for a roll call vote. The Assembly voted not to send the bill to committee; twelve voted to send it, fifteen not to, and six abstained. Rep. Caballero motioned to call to question. There was a roll call vote on calling A.B. 3 to question. The motion to call to question passed 29-2-2, A.B. 3 passed.

Rep. Golemon motioned to suspend the rules in order to hear the newly submitted A.R. 5. The sponsor withdrew the resolution. A.R. 4 STUDENT ASSOCIATION PARKING ON CAMPUS- Rep. Beck motioned for a roll call vote. A.R. 4 failed 5-25-5. Rep. Caballero withdrew his sponsorship from A.R.4.

A.B.01 CHANGING THE NAME OF THE STUDENTS' ASSOCIATION TO THE STUDENT GOVERNMENT- Rep. Aruh was added as a sponsor. The Assembly motioned to call the bill to question. The bill passed.

Announcements were made, the final roll was called and the meeting was finally adjourned at 10:25 P.M.
