## Overview

---

The Hogg Foundation for Mental Health was established on The University of Texas campus in Austin in 1940 with a charge to develop and administer “a broad mental health program for bringing great benefits to the people of Texas.” Over the past 44 years, its staff has sought to fulfill this dream, ever mindful of the hopes of its founders and major donors, Will C. Hogg and his sister, Miss Ima Hogg.

The Foundation’s statewide mandate received special scrutiny and emphasis during 1983–84. Its relationships with the state’s major mental health organizations—the Texas Department of Mental Health and Mental Retardation and the Mental Health Association in Texas—were the subject of meetings with officers of those groups at the spring conference of the Foundation’s National Advisory Council. Staff members traveled throughout Texas to give talks, participate in seminars, lead workshops and to familiarize agency officials with Foundation funding policies and priorities. The Fourth Robert L. Sutherland Seminar in Austin brought together delegates from all areas of the state to examine the mental health of the elderly in Texas and to consider future possibilities on their behalf. Pamphlets and brochures reported innovative mental health efforts evolving from projects or significant meetings. These were published and distributed to thousands of persons with professional or personal interests in mental health.

Activities related to grantmaking—including the review of requests, the offering of consultation and technical assistance, and the making of site visits to previous and potential grant recipients—continue to be the cornerstone of the Hogg Foundation program. That Foundation resources are accessible to all parts of the state and all segments of its population and that these resources may encourage otherwise diverse groups to cooperate in the pursuit of public purpose is the underlying rationale for internally generated activities. The importance of activities initiated by staff as well as grants in support of projects proposed by others was first recognized by members of the Hogg family, a mandate that has been carried forward since.

## Grant-Making Activities

---

### The Will C. Hogg Fund

This fund comprises the endowment for the Hogg Foundation for Mental Health. Monies from the Will C. Hogg Fund may be used for the support of mental health services and research efforts throughout the state of Texas. Grants are made primarily to new projects. Awards vary in size from less than \$1,000 to a maximum of \$40,000 per year with the average annual award in the range of \$10,000 to \$20,000. In the 1983–84 fiscal year, 60 grants totaling \$816,396 were awarded from the Will C. Hogg Fund.

### The Ima Hogg Foundation

This fund, created in 1964 and implemented in 1975, is devoted to the support of direct services to children and their families in the metropolitan area of Houston. Grants from the Ima Hogg Foundation are in the range of \$15,000 to \$50,000 a year. In the 1983–84 fiscal year, 18 grants totaling \$698,372 were awarded by the Ima Hogg Foundation.

### Other Funds

The Foundation oversees several smaller funds including the Mary Yates Memorial Fund, the Ima Hogg Scholarship Fund, the Eloise Helbig Chalmers-Ima Hogg Fund, and the Frances Fowler Wallace Memorial Fund.

### Grant Application Procedures

The Hogg Foundation funds both mental health service and research projects in the state of Texas. Grants are made to nonprofit agencies, organizations, and institutions. Funding criteria include timeliness, relevance, innovativeness, and significance with respect to mental health needs. Funding policies are outlined in detail in the pamphlet *The Hogg Foundation: Programs and Policies for Grants* available from the Foundation on request.

## Inside the Foundation

---

### Mental Health Education

The philosophy of a broad interpretation of mental health continued in 1983–84 via the medium of print and through talks, workshops, and seminars given by various members of the staff. Four general mailings during the year ran the life cycle gamut from review of programs for high risk infants to reports of programs for the elderly.

A total of 124,104 pamphlets was sent in those general mailings to a readership of 10,020 persons. Three other mailings were targeted to selected lists, while special distribution totaling 3,860 pieces of material went out in response to 28 individual orders. Daily requests for Foundation publications were met by provision of 55,228 pamphlets, leaflets, and books.

### Evaluation Research Program

The ninth group of evaluation research fellows held internships during the 1983–84 fiscal year. Two doctoral students were chosen to participate in what has become one of the most prestigious and competitive awards offered in the various academic programs related to mental health. Aside from participation in the evaluation research seminar at UT Austin and active involvement in Foundation funded projects, this year's fellows became intimately involved in the planning and the execution of the Fourth Robert Lee Sutherland Seminar.

### The Robert Lee Sutherland Seminar

The Robert Lee Sutherland Seminars have continued, following a tradition begun shortly after the death of the Foundation's first president in 1976. Held biennially, each seminar has a distinct theme.

The fourth seminar, which took place in Austin in May of 1984, was entitled "Looking Forward" and dealt with both a present and "futures" study of the area of aging in Texas. The 250 invited guests heard national speakers and deliberated in small group shops to deal with some of the specific

## Libraries

### *Hogg Foundation Library*

The Hogg Foundation Library, available for use by University faculty and staff, students, and the general public, focuses on all aspects of mental health and allied fields and contains a specialized collection of books, journals, and vertical file materials relating to the broad areas of mental health, community, and aging.

### *Regional Foundation Library*

The Regional Foundation Library, one of over 140 regional collections of the Foundation Center, serves as a clearinghouse for information on foundations and grantsmanship. As such, it contains all of the publications of the Foundation Center plus microfiche copies of the Internal Revenue Service tax returns for all private foundations in Texas. In addition, it contains over 300 books, periodicals, and materials on fund raising and grant proposal writing. Approximately 800 people used the Regional Foundation Library resources during 1983–84. Library hours are 8:00 a.m. to 5:00 p.m. on weekdays.

## Other Internal Activities

A variety of other program activities took place within the Foundation during the year. These included the planning of a cross-cultural research and training conference, the provision of an evaluation consultant to a local treatment program, and the completion of a self-assessment manual for voluntary organizations. The Robert Lee Sutherland Conference Room was used by various groups 70 times during the year. The semi-annual National Advisory Council meetings were held this year in El Paso and Lakeway.

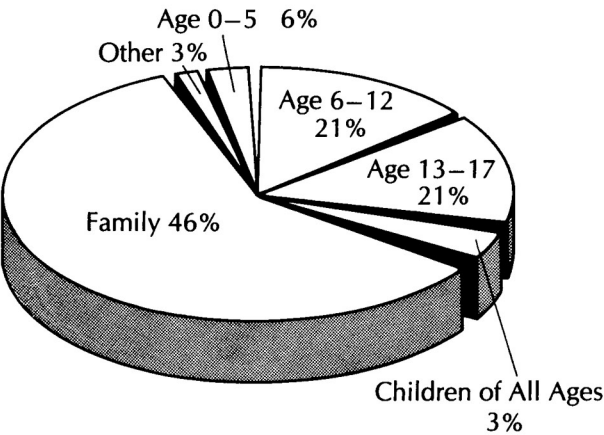

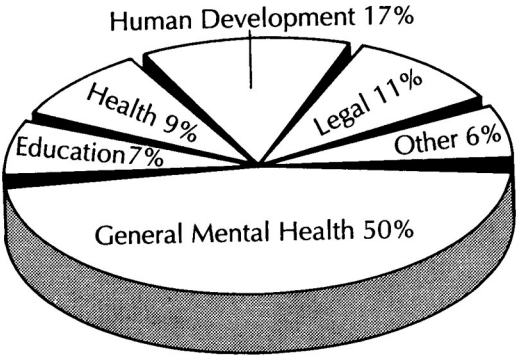

by Service Recipient Age Groups**



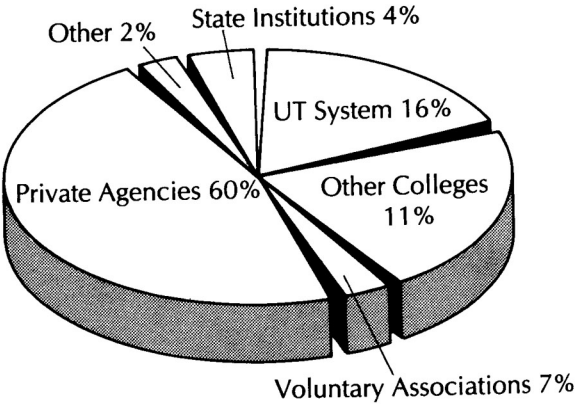

by Service Recipient Age Group**



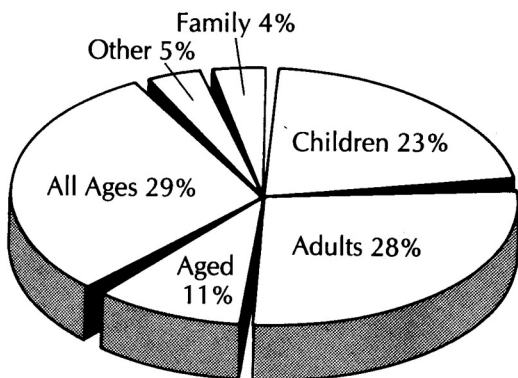

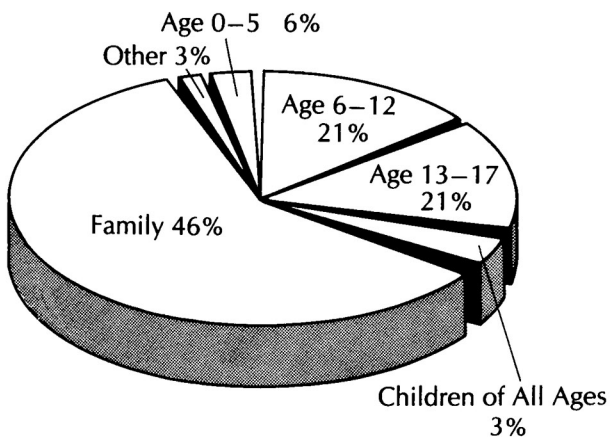
