Overview

The Hogg Foundation for Mental Health was founded within The University of Texas in 1940 with a charge to develop and administer “a broad mental health program for bringing great benefits to the people of Texas.” Over the past 48 years, its staff has sought to fulfill this mandate, ever mindful of the hopes of its founders and major donors, Will C. Hogg, his sister, Miss Ima Hogg, and other members of the Hogg family.

The Foundation’s statewide mandate continued to receive special emphasis and further development during 1987–1988. Activities related to grant-making—including the review of requests, the offering of consultation and technical assistance, and the making of site visits to previous and potential grant recipients—continue to be the cornerstone of the Hogg Foundation program. In 1987–1988, 82 grants totaling \$1,746,119 were awarded through the Will C. Hogg Fund and the Ima Hogg Foundation. Major emphases of the grants programs were innovations in direct mental health service, mental health research, and mental health program development. Awards were also made for professional training and mental health education.

Foundation resources are accessible to all parts of the state and all segments of its population, often encouraging otherwise diverse groups to cooperate in the pursuit of public purpose. The importance of activities initiated by staff, as well as grants in support of projects proposed by others, was first recognized by members of the Hogg family and has been carried forward since.

Staff members traveled throughout Texas during 1987–1988 to give talks, participate in seminars, lead workshops, and familiarize agency officials with Foundation funding policies and priorities. Pamphlets and brochures reported innovative mental health efforts evolving from projects or significant meetings. These were published and distributed to thousands of persons with professional or personal interests in mental health.

Grant-Making Activities

The Will C. Hogg Fund

This fund comprises the endowment for the Hogg Foundation for Mental Health. Monies from the Will C. Hogg Fund may be used for the support of mental health services and research efforts throughout the state of Texas. Grants are made primarily to new projects. Awards vary in size from less than \$1,000 to a maximum of \$50,000 per year with the average annual award in the range of \$10,000 to \$20,000. In the 1987–1988 fiscal year, 62 grants totaling \$929,844 were awarded from the Will C. Hogg Fund.

The Ima Hogg Foundation

This fund, created in 1964 and implemented in 1975, is devoted to the support of direct services to children and their families in the metropolitan area of Houston. Grants from the Ima Hogg Foundation are generally in the range of \$15,000 to \$80,000 a year. In the 1987–1988 fiscal year, 20 grants totaling \$816,275 were awarded by the Ima Hogg Foundation.

Other Funds

The Foundation oversees several smaller funds including the Ima Hogg Scholarship Fund, the Frances Fowler Wallace Memorial Fund, the DeRossette Thomas Fund, and the Varner-Bayou Bend Heritage Fund. Occasionally grants are made from one of these special funds or gifts are made from the interest accrued by these endowments.

Grant Application Procedures

The Hogg Foundation funds both mental health service and research projects in the state of Texas. Grants are made to nonprofit agencies, organizations, and institutions. Funding criteria include timeliness, relevance, innovativeness, and significance with respect to mental health needs. Inside the Foundation

Mental Health Education

The philosophy of a broad interpretation of mental health continued in 1987–1988 via the medium of print and through talks, workshops, and seminars given by members of the staff. A new book, *Analysis of the Texas Mental Health Code*, was distributed widely. Three general mailings during the year contained nine new pamphlets and leaflets ranging from:

- ...an insightful report of a project working with suicidal adolescents and their families
- ...to a pamphlet describing findings of a study examining factors associated with success in dual career marriages.

A total of 75,816 publications was sent in those general mailings to a readership of 7,950 persons. Six other mailings containing 899 publications were targeted to selected lists. Special distributions totaling 7,450 pieces of literature went out in response to 79 individual requests. Daily requests for Foundation publications were met by provision of 33,125 pamphlets, leaflets, and books.

Evaluation Research Program

This Fellowship, which continues to be one of the most prestigious at The University of Texas at Austin, differs from most other graduate study awards in the fact that recipients become vital parts of the Foundation staff, working as half-time interns in the evaluation of Foundation-funded projects. Participation in two seminars convened with the Foundation's Vice President in the fall semester and the President in the spring semester provides a structured opportunity for the study and further development of evaluation techniques. This year's Fellows developed a major internal evaluation of service delivery projects funded over the last decade or so by the Foundation. They also worked independently with specific, currently funded programs.

Additionally, the 1987–1988 Fellows have served as program staff with the three Commissions described below. They participated in numerous commission meetings, synthesized current knowledge in requested areas, and built new knowledge where gaps existed. Each commission is furthered in meeting its objectives by the efforts of these persons as research associates.

Ima Hogg Scholarships

In this, the third year of scholarship awards from this newly reactivated fund, the decision was made to make only one award at a significantly higher level with the goal of enabling the recipient to pursue the graduate degree without the need for outside employment. The number of second- and third-year candidates expressing interest in careers in mental health services to children and their families continues to grow dramatically. The scholarship committee, composed of the Foundation's President, Vice President, and Faculty Advisors, found selection of one recipient from this outstanding group of graduate scholars a difficult task.

Other Internal Activities

Three statewide commissions appointed in 1987 completed the first year of their study of issues related to the mental health of three Texas populations—the chronically mentally ill, children and their families, and adolescents and young adults. The first commission focused on technological innovations, training and education of mental health personnel, and collaboration of state and local agencies in the care and treatment of the chronically mentally ill in the community. The second commission concentrated on the problems of children from birth to age 6, with an emphasis on parenting, child care, education, and health and development. The third commission directed its efforts toward adolescents at risk, studying risk factors, influences on healthy teen development, and possible modes of problem prevention. Based on these and further studies, each commission will recommend actions designed to help resolve the mental health issues of the three target populations. Other planned byproducts of commission activities include conferences, video presentations, and booklets. The commissions' work will culminate with reports that will be presented as part of the Hogg Foundation's fiftieth anniversary commemoration in 1990.

The Foundation hosted professional and volunteer groups within the field of mental health. The Sutherland Conference Room was used by various groups 113 times during the year. Professional staff members served as officers or board members of a number of state and national organizations concerned with mental health or philanthropy. These professional staff members also supervised the work of Evaluation Research Fellows and Research Associates who served as consultants to several Foundation-funded projects.

The semi-annual National Advisory Council meetings were held this year in Austin and Lakeway.

Libraries

Hogg Foundation Library

The Hogg Foundation Library, available for use by University faculty and staff, students, and the general public, focuses on all aspects of mental health and allied fields and contains a specialized collection of books, journals, and vertical file materials relating to the broad areas of mental health, community, and aging.

Regional Foundation Library

The Regional Foundation Library, one of over 160 regional collections of the Foundation Center, serves as clearinghouse for information on foundations and grantsmanship. As such, it contains all of the publications of the Foundation Center plus microfiche copies of the Internal Revenue Service tax returns for all private foundations in Texas. In addition, it contains over 300 books, periodicals, and materials on fund raising and grant proposal writing. Approximately 737 people used the Regional Foundation Library resources during 1987–1988. Library hours are 8:00 a.m. to 5:00 p.m. Monday through Friday.

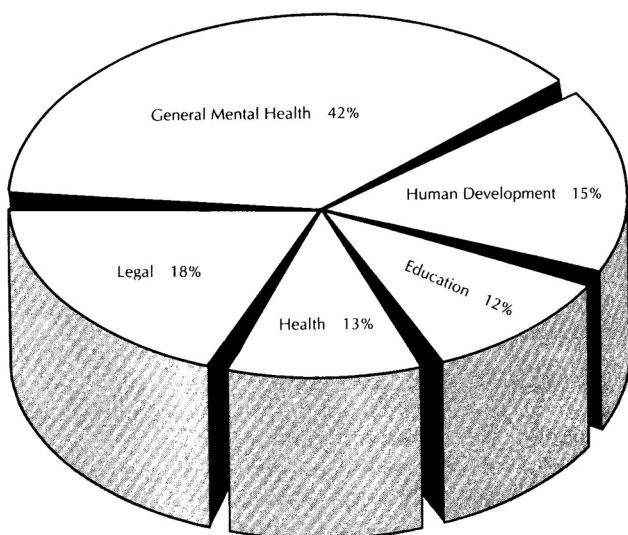

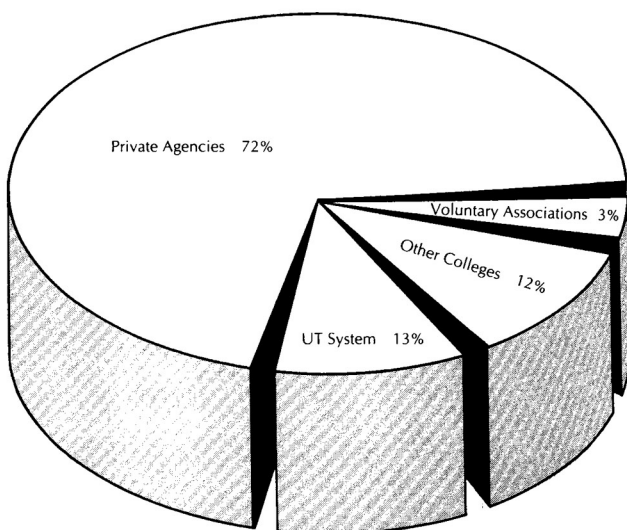

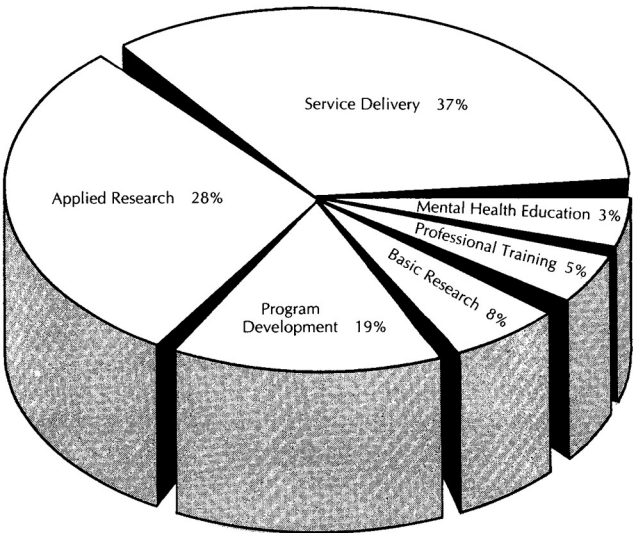
Foundation Grants by Problem Area



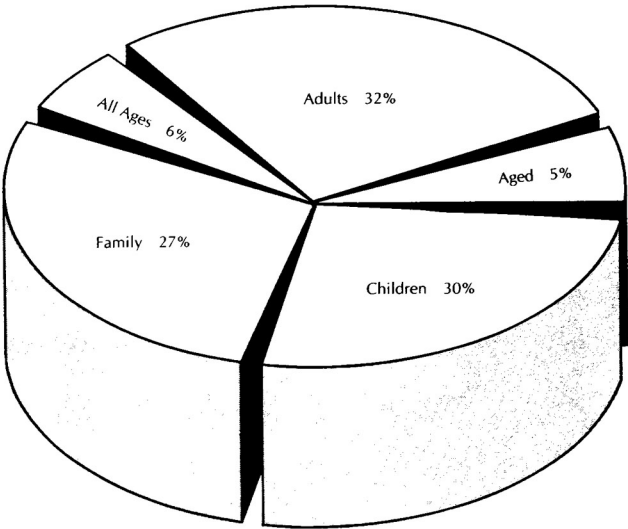
Foundation Grants by Recipient Organization



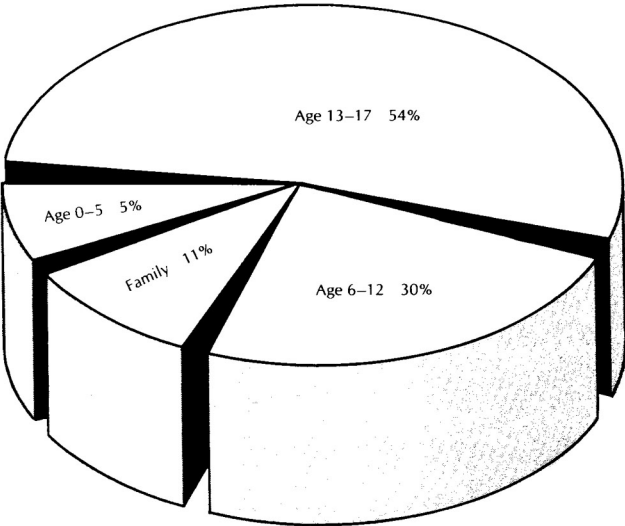
Will C. Hogg Fund Grants by Project Type
