1. SINCE, APART FROM FEW EXCEPTIONAL CASES WITH WIHCH YDU ARE FAMILIAR, US PRESS HAS SHOWN NO INTEREST IN QUOTE GOVERNMENT EMPLOYEE'S EXCHANGE UNQUOTE REFERENCES TO YOU, DOUBT ANY US CORRESPONDENTS NOW IN PRAGUE WILL RAISE SUBJECT.

2. IF SUBJECT RAISED BELIEVE BEST COURSE ACTION IS FOR YOU

AS YOU WILL RECALL FROM OUR CONVERSATION OF FEBRUARY 8, I EXPRESSED BY DEEP DISTRESS OVER RIDICULOUS CHARGES PUBLISHED IN INNER QUOTE GOVERNMENT EMPLOYEE'S EXCHANGE END INNER QUOTE AND OTHER NEWSPAPERS REGARDING RELATIONSHIPS BETWEEN MRS. MICHALOWSKA AND AMBASSADOR BEAM. I KNOW HOW DISAGREEABLE THIS HAS BEEN FOR YOU AND YOUR FAMILY. WE PLACE A HIGH VALUE IN THIS COUNTRY UPON INSTITUTION OF FREE PRESS. WE DO NOT CONDONE, HOWEVER, ABUSE OF THIS INSTITUTION BY UNSCRUPULOUS PERSONS. AS YOU ARE AWARE, ONLY LEGAL MEANS TO DEAL WITH THIS UNPLEASANTNESS ARE THROUGH THE COURTS, AND WE RECOGNIZE

THAT TO FILE SUIT WOULD ONLY GIVE RISE TO FURTHER PUBLICITY
OF KIND WE UNDERSTAND YOU WOULD WISH TO AVOID.

I WANT TO ASSURE YOU THAT NO ONE IN DEPARTMENT OF STATE FAMILIAR WITH BACKGROUND OF THIS MATTER PLACES ANY CREDENCE WHATSOEVER IN THESE CHARGES. I AND MY COLLEAGGUES VERY MUCH REGRET INDIGNITY YOU AND YOUR FAMILY HAVE SUFFERED. UNGUSTE.

4. ALTHOUGH LETTER IS INTENDED BY MICHALOWSKI FOR USE WITH HIS FOREIGN OFFICE, IT WAS SO DRAFTED THAT IF IT SHOULD BECOME DESIRABLE AT SOME LATER TIME TO RELEASE IT TO THE PRESS. WE COULD DO SO, SUBJECT YOU YOUR APPROVAL AND THAT OF MICHALOWSKI. RUSK
