#### XII. Unfinished Business

- A. AR 27 In Support of Maintaining Current Tuition Residency Law
  - i. Butler-LPC met last Tuesday right after meeting, made a few changes. Clarifying "appeal" and change some language.
  - ii. Constituent- This resolution to me comes down to other students to continue to go to this university. To have the ability to even go to a college in a state of Texas. This sets up an avenue for them to do so. It doesn't set up affirmative action style standard. It's just a uniform standard that other citizens are held to. It's an issue of fairness. The main arguments I've heard is that it is unfair that undocumented students are able to pay instate tuition. Undocumented students contribute 18billion dollars a year; while out of state students don't make that contribution. These kids come from out of the US, but not

There are certainly talking about lawsuits, and the move to repeal this piece is very real. With regards to the A&M thing this only came after that by way of coincidence. This is the way the conversation has been moving the last couple months. A part of me really wants to alter this conversation.
