 - a. Q: Hooper: sec.4 leg would only accept Texas state id? 2nd whereas how does it fit in?

- i. A: Talarico: residency change would have to change, could complicate things, vague
- b. Q: Meyerson: this is way better. 4th whereas does Texas have a law about whether expiration date needed?
 - A: Talarico: No; law doesn't explicitly state "student" ids
- c. Q: Minator: Any id from state agency would be acceptable, UT is state agency
 - Talarico: doesn't explicitly say student IDs, so vague
- d. Minator: strikeout 2nd whereas on back page?
 - Talarico: problem is that on election day, pollworkers may get confused and could deny students who use their school ID
- e. Hooper: POI does it say whether UT ids will be allowed?
 - i. Its implicit, but concern is that no expiration date on UT ids
 - ii. Castetter: Senators haven't looked at UT ids in a while, so cause for concern

DEBATE

- a. Talarico: this legislation has been seen multiple times, gone through a long evolution
- b. Ferrarro: we want to make sure that if they do pass something, that it won't hurt students

B. AR4: In Support of the DREAM Act

- 1. Questions
 - a. Hard to give exact numbers
 - b. Example of UT student nurse that would benefit from DREAM Act
 - c. Talarico: Stein added a few whereas clauses to make more poetic; wording cleared up
 - d. Friendly amendment: 2nd whereas change to professionals
 - e. Intended for those that have lived in Texas for 5 years
 - f. Rosen: clarify 6th whereas
 - i. Lopez: not just for undocumented, but for legalized too
 - g. Woods: would this increase diversity?
 - i. Talarico: not the focus, it is to help those trying to enter workforce after graduation
 - ii. Lopez: wont change admissions process
 - h. Woods: if were sending this to US Congress they may like that it increases diversity, but not affirmative action
 - i. Woods: motion or friendly amendment in 2nd BIR "passage of the dream act could increase diversity at the university of Texas and..." – passes
 - j. Castetter: friendly amendment un-bold two T's and others

2. Debate

a. Yay - Authors: It is so sad to see potential contributors to economy/society pushed to sideline

- Nay Rosen: creates bad precedent creates incentive for illegal immigrants
- c. PI Yue: illegal immigrants do pay taxes
- d. Yay O'dell: law already in place to put them through school and then they are left with no career. We can't deny that they want to benefit society
- e. Nay Rosen: fear that this will prolong the problem of illegal immigration
- f. Yay Talarico: broken immigration system is beyond our control, look at reality and do what we can to help and take advantage of opportunities – stay focused on UT students
- g. Nay Lewis: illegal immigrants are getting preferential treatment over Americans in admissions and tuition
- h. Yay Guest: requirement is that they must be resident in Texas for 5 years among other requirements; personal story about sister and mother
- i. Nay Gohlke: cost issue
- j. Yay Ferraro: not the intent of this bill
- k. Nay Lewis: need to be protecting Americans first, especially in this economy
- Yay O'dell: immigrants pay more in taxes than they use from public services; I worked part-time job for a year and then got instate tuition
- m. Gohlke: move to roll call vote
- n. AR 4 Fails
- o. Motion to reconsider
- p. Objection
- q. Move to debate to reconsider vote or not
- r. Yay Woods: really affects UT students; many abstentions may want to reconsider
- s. Nay Hooper: you were elected to make decisions; abstain if conflict of interest or lack of info

- Nay Rosen: we should not reconsider voting because you had your chance to vote and failed to speak up, now it didn't turn out how you want, so you wan revote, sets bad precedent
