In opposition of AR 3 As former student body presidents and vice-presidents at the University of Texas at Austin, we wright to express our concern over the recently introduced legislation AR-3 regarding the Boycott, Divestment and sanctions movement or BDS, which aims to divest UTIMCO from certain companies that do business in the State of Israel. As past leaders of the University, we appreciate your tircless work to enhance and improve the 40 acres while pursuing policies at the local, state and national levels that enhance the student experience and support higher education. As the Student Government website states, SG is "recognized as 'the official voice of students,' and we don't talk it lightly." During our respective leadership terms we each faced and took on significant issues aimed at improving student life and the student experience. We worked endlessly to bring students together. We strived to promote responsible and fair dialogue. One of the UT's greatest benefits is its diversity and the exposure to divergent opinion that bombards its students on a daily basis. Just as

we commend SG for considering this difficult issues, we urge SG to conclude that BDS is not a movement its members should support. The BDS movement is rooted in a philosophy that advocates the destruction of Israel and its inhabitants. We do not think the Student Government assembly should align itself with such a philosophy. As individuals passionately and actively involved on all sides of the political spectrum, we also note that strong relationships exist between Israel and Texas. Such relationships are based on the common values of freedom and democracy. Texas' relationship with Israel goes back decades. Our state's department of Agriculture is regularly trained by its Israeli counterpart on how best to leverage water technology and other agricultural innovations. Police officers and first responders throughout the state regularly engage with those in Israel to better prepare to safeguard our cities and counties. There is much that the state of Texas and Israel share, and the BDS movement attempts to undermine that relationship. As the official voice of the student body we strongly urge you to vote down the BDS legislation AR-3. UT's greatest strength is the diversity and passion - TIME

VII. Unfinished Business

- a. A.B. 1 Establishing the Executive Appointment Oversight Committee
 - i. All appointments must be sworn-in to office by a Justice of the Supreme Court before they may assume their duties and powers of office and approved by a 2/3 majority in the Assembly. A 2/3 majority in the Assembly can also remove them if the job is not fulfilled. The Executive Appointment Oversight Committee, consisting of the Speaker, one member of the Assembly Board and one at-large member from the Assembly who is not on the Assembly Board, will give the general assembly a report on the quality of the interview process prior to an appointment being voted on by the Assembly. A list of all presidential appointments shall be available by a link from the Student Government

homepage. The Administrative Director shall make all appointment applications available to the members of the Assembly.  - i. AR 1's purpose is to improve the freshman experience. The resolution speaks to the importance of freshman year for the academic success, social integration, and mental and physical health. The resolution also states student success during the first year encourages them to return the second year, improves their confidence in their ability to succeed in all four years of college and solidifies their commitment to graduating. The resolution quotes two studies from the University of California at Los Angeles on how important investments in the freshman experience are for the success of all students. The legislation concludes that Student Government supports improving student life and academics for freshman with improvements in tutoring, dining options, etc.

need accommodations for exams during special circumstances such as a death in the family, excused sickness, required to travel and participate with UT activities etc. The resolution also states that it is not the responsibility for Services for Students with Disabilities to provide these assistances as it currently falls under the staff of SSD. The legislation concludes that the benefits of the adding the testing center to the Austin campus would relieve the overburden staff of SSD; therefore, they can better fulfill their job of ensuring that students with disabilities have an equitable student life experience at UT. The resolution extends beyond students with disabilities and allows for the service that all students at most major intuitions in the state are able to receive.

AR 3's purpose is to call upon the University of Texas System and UTIMCO to appoint an ad hoc committee to investigate all companies stated to be directly or indirectly violating international law in the Israeli-Palestinian geographical region. Furthermore, the resolution asks for the divestment within one year from companies found in violation without causing injury to UT assets and investment strategies.
