A.B 14 NATIONAL COLLEGIATE ALCOHOL AWARENESS WEEK

A BILL TO BE ENTITLED AN ACT

ALLOTING FUNDS FOR THE COORDINATION OF NATIONAL COLLEGIATE ALCOHOL AWARENESS WEEK, AND DECLARING AN EMERGENCY; NOW THEREFORE,

Be it enacted by The Student Assembly of The University of Texas that:

SECTION I: The Students Association will allot \$1,000.00 for National Collegiate Alcohol Awareness Week for the purpose of publicity and coordination from the General Fund..

SECTION II: This week will be held October 16-22, 1988.

SECTION III: Any funds not used for National Collegiate Alcohol Awareness Week will be returned to the Students Association.

SECTION IV: If any part of this Act is to be held invalid, the remaining portions will remain unaffected.
