**A.B. 10 To Create a Shuttle Bus Transportation Agency**

**A BILL TO BE ENTITLED AN ACT**

**ESTABLISHING A STUDENT GOVERNMENT AGENCY TO ADDRESS THE NEEDS OF STUDENTS REGARDING CAMPUS TRANSPORTATION AND THE IMPROVEMENT OF THE UT SHUTTLE BUS SYSTEM**

To modify the Internal Rules of Procedure for the Student Government of the University of Texas at Austin:

Be it enacted by the Assembly of the Student Government of the University of Texas at Austin:

Section 1: Amend the Internal Rules of Procedure for the Student Government of the University of Texas at Austin, by inserting the following after Article XXII, and renumbering any following articles.

**ARTICLE XXIII**

**Shuttle Bus Transportation Agency**

Section 1: The mission of the Shuttle Bus Transportation Agency is to improve the quality of the UT shuttle bus services. The Agency will provide a formal channel of communication between students and the UT Shuttle Bus Committee Members, and serve as an outlet for action on transportation issues.

Section 2: The Agency's mission will be accomplished by soliciting input from students, collecting data, and recommending plans for improvement of the safety, scheduling, routing, and overall performance of shuttle services. The resulting information shall be instrumental in the decision-making processes of both the Student Services Fee Committee and the UT Shuttle Bus Committee. The Agency shall be charged with the duty to ascertain that the allocation of student fee money to Shuttle Bus Services, which is consistently upwards of \$4.5 million dollars, provides a high-quality, efficient service to students.

Section 3: The two student Co-Directors of the Agency shall also be appointed to serve, along with the President or Vice President, as voting members on the UT Shuttle Bus Committee. The Co-Directors shall begin work on the business of the Agency immediately following appointment, and shall begin work on the UT Shuttle Bus Committee at the first Fall Semester meeting of that body.

- Section 4: No Co-Director shall be appointed to the Agency unless the President also recommends their appointment as a voting member on the UT Shuttle Bus Committee. The President or Vice President shall not serve as Co-Director of the Agency.
- Section 5: The Co-Directors shall be responsible for the administration and operations of the Agency. They shall organize weekly meetings, coordinate research efforts, and develop plans of action to recommend at each meeting of the UT Shuttle Bus Committee. The Agency's Directors shall also solicit and catalog student complaints and suggestions for presentation to the UT Shuttle Bus Committee. The Co-Directors shall have the power to create additional positions within the Agency.
- Section 6: The term for the Co-Directors shall be one year. The Co-Directors may reapply for appointment.
- Section 7: The Shuttle Bus Transportation Agency shall be open to all students at the University of Texas at Austin.
