

**A. B. 27 Bylaws on The Enabled Students' Resource Center**

A BILL TO BE ENTITLED AN ACT

TO ADD ARTICLE XIV AND RENUMBER CURRENT ARTICLES XIV AND XV, AND MODIFY CURRENT ARTICLE XIV (HEREAFTER REFERRED TO AS ARTICLE XV) OF THE STUDENTS' ASSOCIATION BYLAWS CONCERNING THE CREATION OF THE ENABLED STUDENTS' RESOURCE CENTER ; NOW THEREFORE, BE IT ENACTED BY THE STUDENTS' ASSOCIATION THAT:

*Be it enacted by the Student Assembly that:*

**SECTION I:** Article XIV Enabled Students' Resource Center will be added to the Students' Association Bylaws and all other Articles will be renumbered. The Enabled Students' Resource Center will be added as follows:

section 1: The purpose of the Enabled Students' Resource Center is to enhance services to students with disabilities in the form of information, such as, adaptable job opportunities, purchasable adaptive equipment, integrational programs, all of which designed to broaden the independence of students with disabilities.

section 2: The Enabled Students' Resource Center shall have one director recommended by either, A.B.L.E. or the Disabled Advisor of the Students Association and appointed by the president of the Students Association.

section 3: The Enabled Students' Resource Center Director shall be approved by a majority of the Assembly.

section 4: The Director of the Enabled Students' Resource Center agency is the chief operating officer who establishes the rules of procedure for the agency, manages all its finances and properties. Members of the agency will be chosen by its director.

section 5: The term of the director shall be one year and be procedure for re-appointment.

section 6: The Director of the Enabled Resource Students' Center may be removed after an Internal Affairs review and, if warranted may present it to the floor for a formal removal by 2/3 majority. The new director must be appointed within fifteen days.

**SECTION II:** The renumbered Article XV involving STIPENDS should add a section 7 which will read as follows:

section 7: The Director of the Enabled Students' Resource Center shall receive an annual stipend of sixteen hundred dollars (\$1600) or one hundred thirty three dollars and thirty three cents a month (\$133.33) .
